### *“Our Trust To You”*

- *Christ Church Cathedral Memorial Garden will be maintained in perpetuity [as defined] and will always be under the control and direction of The Dean and Chapter of Christ Church Cathedral, Newcastle.*
  - *Burial of cremated remains will be directly into the earth without enclosure.*
  - *Placement of ashes in the Memorial Garden will be considered final. Ashes cannot be removed or relocated.*
    - *There will be no special markings or plantings for individual placement.*
- *Since precise site identification will remain anonymous, individual location markers and other site decorations will not be permitted.*
  - *A permanent record of each burial will be kept by the Cathedral in a Book of Remembrance.*
    - *An optional website record is offered.*
- *A fee (non-refundable) per placement is required on application and this fee will be held in a Permanent Trust set up exclusively for the maintenance and upkeep of the Memorial Garden grounds in perpetuity.*
